

Captivate CMA Financial Industry Webinar Sweepstakes Official Rules.

No Purchase Necessary to Enter or Win. Purchasing Will Not Increase Your Chances of Winning.

“**Captivate CMA Financial Industry Webinar Sweepstakes**” (the “**Sweepstakes**”) sponsored by Captivate LLC (“**Sponsor**”) begins 12:01 a.m. Eastern Time (“**ET**”) on February 23, 2021 and ends 11:59 p.m. ET on March 1, 2021 (the “**Sweepstakes Period**”).

1. **ELIGIBILITY:** Sweepstakes are open to legal residents of Canada (excluding Quebec), who are at least 18 years of age (“**Entrant**” or “**Entrants**”). Employees, representatives, mandataries, members of the jury (if any), officers and directors of Captivate LLC (“**Captivate**”), and their respective parents, subsidiaries, affiliates, dealerships, promotion, public relations and advertising agencies and members of their immediate family (spouse, mother, father, sister, brother, ward, daughter or son) and persons living in the same household of such employees, officer or directors, are not eligible to enter or win. If the identity of an Entrant is disputed, the authorized account holder associated with the email at the time of Entry will be deemed to be the Entrant. 7. **Prize:** Two (2) grand prize winners (the “**Grand Prize Winner**”) will receive one (1) Gift Card (“**Prize** or **Grand Prize**”). Approximate retail value (“**ARV**”) of Grand Prize: \$50.

Potential winner may be required to sign and return an affidavit of eligibility and liability, and unless prohibited, a publicity release within seven (7) days of date appearing on prize notification and correctly answer a time limited mathematical skill-testing question without the assistance or mechanical or electronic aids.
